DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: U.S. COAST GUARD AIDS TO NAVIGATION PROGRAM

Description of Proposal: The Coast Guard (CG) is responsible for maintaining the U.S. Aids to Navigation (ATON) System. This system employs a simple arrangement of colors, shapes, numbers and light characteristics to mark navigable channels, waterways and obstructions adjacent to these. ATONs provide the same type of information drivers get from street signs, stop signals, road barriers, detours and traffic lights. They may be anything from lighted structures, beacons, day markers, range lights, fog signals and landmarks to floating buoys. Each has a purpose and helps in determining location, getting from one place to another or staying out of danger. The goal is to promote safe navigation on the waterway. The primary components of the ATON System are beacons, and buoys. Beacons are aids to navigation structures that are permanently fixed. They range from lighthouses to small, single-pile structures and may be located on land or in the water. Lighted beacons are called lights; unlighted beacons are called daybeacons. Beacons exhibit a daymark to make them readily visible and easily identifiable against background conditions. The CG has statutory responsibility to operate and maintain the system to facilitate navigation and to prevent ships from running aground or collisions. To fulfill this mission, the Coast Guard operates over 53,000 aids. There are over 1,500 aids in Washington. Once thousand of those are pile supported structures.

Maintaining the ATON system requires repairing and replacing existing aids, minor relocations, and the occasional installation of new aids to address changed navigation conditions. Three designs are used depending on the need. A one pile structure is typically used to mark a channel edge. The three or four pile structure design is used if greater visibility is required or the area is prone to vessel collisions. Each structure is constructed with 18" hollow steel pile that is vibrated into the bottom. It typically takes between 2 to 8 hours to complete a structure. Drawings and photographs are provided as enclosure (1). These structures are used anywhere there is boat traffic.


