## **DETERMINATION OF NONSIGNIFICANCE (DNS)**

Name of Proposal: BLUE MOUNTAIN ELK FENCE, SCHOOL FIRE

RECONSTRUCTION

**Description of Proposal:** Reconstruction of approximately 8.5 miles of the elk fence that was damaged in the School fire of 2005 will include demolition and removal of the existing damaged elk fence and construction in the same alignment, using the same type materials.

Demolition will consist of removing burned wood fence materials and piling in stacks of 20 pieces, more or less, on WDFW property near the fence and removing steel fencing wire from the site. Construction will consist of embedding treated wood fence posts 2.5' into the ground and stapling 8' tall 6" x 6" wire mesh to them. Some 12' wide swing gates and some one-way gates will be installed at their original locations. Where posts cannot be buried due to the rocky soil, rockjacks will be constructed to provide fence stability (see the drawings for a rockjack example). Due to the remote location of parts of this fence, materials may be brought to the fence site by helicopter. Equipment used will be restricted to hand operated tools only. Please see attached plans for construction techniques and design.

The fence will be constructed by Department of Corrections (DOC) inmate crews working under the direction of Department of Natural Resources (DNR) supervisors, and will be guarded by DOC guards. The work force of approximately 80 personnel will camp near the WDFW Wooten Wildlife Area Headquarters on Tucannon Road, with DNR supplying all sanitary, cooking and lodging needs

**Location of Proposal, including street, if any:** The main access point for this repair work will be the Wooten Wildlife Area, located on the Tucannon Road, 19 miles from State Route 12. The secondary access point will be the Mountain Road, 8 miles from Pomeroy. Fence repair will occur on the boundary of the Wooten Wildlife Area between these two access points. As shown on the attached site plan, work will done from point F to point FF, and from point K to point W.

The work will be in Section 3 of T9N, R42E; Sections 19, 20, 29 of T10N, R42E; Sections 13, 15, 16, 21, 22, 23, 24 of T10N, R41E, W.M. Garfield County; Washington

**Lead Agency:** Washington Department of Fish and Wildlife (WDFW)
