### ENVIRONMENTAL CHECKLIST

#### *Purpose of checklist:*

The State Environmental Policy Act (SEPA), chapter 43.21C RCW, requires all governmental agencies to consider the environmental impacts of a proposal before making decisions. An environmental impact statement (EIS) must be prepared for all proposals with probable significant adverse impacts on the quality of the environment. The purpose of this checklist is to provide information to help you and the agency identify impacts from your proposal (and to reduce or avoid impacts from the proposal, if it can be done) and to help the agency decide whether an EIS is required.

#### *Instructions for applicants:*

This environmental checklist asks you to describe some basic information about your proposal. Governmental agencies use this checklist to determine whether the environmental impacts of your proposal are significant, requiring preparation of an EIS. Answer the questions briefly, with the most precise information known, or give the best description you can.

You must answer each question accurately and carefully, to the best of your knowledge. In most cases, you should be able to answer the questions from your own observations or project plans without the need to hire experts. If you really do not know the answer, or if a question does not apply to your proposal, write "do not know" or "does not apply." *WDFW proposes to do this project in summer of 2012.*

7. Do you have any plans for future additions, expansion, or further activity related to or connected with this proposal? If yes, explain.

*No additional activity is planned for this project.*

*No additional biological information will be prepared.*

*There are no known pending applications associated with or affecting this project.*

*A Pend Oreille County Shoreline Permit, WDFW Hydraulic Project Approval, Army CORP of Engineers Section 404 Permit, and Ecology 401 Water Quality Certification will be needed. A DNR Aquatic Lands Lease is also in process.*

11. Give brief, complete description of your proposal, including the proposed uses and the size of the project and site. *This project involves the renovation of an existing WDFW boat launch ramp and access site on Diamond Lake. This double ramp is scheduled to be replaced and an associated boarding float will be installed. A concrete abutment and additional ADA parking stalls will also be installed. This public access is currently open and operating but repairs are necessary to provide continued use in future years.*

The specific components of this project are:

1. *Remove two dilapidated concrete boat ramps at the WDFW public access site. Unbroken ramp planks will be salvaged for use at other sites. Damaged concrete ramps will be hauled offsite to a nearby landfill.*
2. *Install two new concrete ramps by connecting 4 foot by 12 foot precast concrete sections. The two new ramps will each measure 12 feet wide and 52 feet long. The ramps will be bedded on a 4 inch pad of crushed rock.*
3. *Install Armor flex concrete blocking (mat) at the bottom, middle and sides of each ramp to protect ramps from erosion and undermining. The two outside edges of the ramps will each have a 52 foot long by 4 foot wide section of Armor flex installed. The bottom edge of the ramps will both be protected with an 8 foot by 42 foot section of Armor flex. In between the two ramps a 10 foot by 36 foot section of Armor flex will be installed.*
4. *Install a concrete abutment in between the two ramps that will secure and provide access to the float. This abutment will measure 6'3" wide and 16 feet long. Height will be variable.*
5. *Drive two 8 inch steel pilings to secure float.*
6. *Install a 6'3" wide by 60 foot boarding float. The new float will be located between the new ramps.*
7. *Replace existing asphalt curb at the lake edge with a new concrete curb in the same footprint. This curb will be 12 inches above grade on the outer edge and 7 inches above grade on the parking lot side.*
8. *Repair broken asphalt edges by saw cutting and removing damaged areas and replacing with new asphalt. Two bollards will also be removed.*
9. *Asphalt pave center of existing parking area that is currently compact gravel.*
10. *Install one new ADA parking stall and ADA unloading area by removing existing asphalt, repaving and painting new parking area. Two wheelstops will also be installed for ADA parking.*
11. *Install 8 foot by 12 foot water dissipater at the west edge of the parking lot. This dissipater will be constructed of light loose rip rap. Ditches on both sides of access road will also be clean and re-graded.*
12. *Perform mitigation measures. This will entail removing a section of asphalt and replanting that area with native shrubs.*

12. Location of the proposal. *The Diamond Lake Public Access Site is located at the Northeast end of Diamond Lake in the town of Diamond Lake. This site is reached by heading Southeast on Highway 2 from Newport for 7 miles, before turning right onto Green Road. After turning onto Green Road take an immediate right onto South Shore Road. The boat launch is immediately on the left after turning onto South Shore Road. The project site is in Pend Oreille County, Section 1, Township 30 North, Range 44 East. The parcel number is 443001549063.*

## B. ENVIRONMENTAL ELEMENTS

### 1. Earth

a. General description of the site (circle one): Flat, rolling, hilly, steep slopes, mountainous, other . . . . .

b. What is the steepest slope on the site (approximate percent slope)?

*25%.*

c. What general types of soils are found on the site (for example, clay, sand, gravel, peat, muck)? If you know the classification of agricultural soils, specify them and note any prime farmland.

*The soil is classified as Orwig Sandy Loam. Most of the site however is surfaced with imported crushed rock aggregate.*

d. Are there surface indications or history of unstable soils in the immediate vicinity? If so, describe.

*There are no indications of unstable soils.*

e. Describe the purpose, type, and approximate quantities of any filling or grading proposed. Indicate source of fill.

*There will be a net gain in fill as the new ramp is larger than the old ramp to be removed. Armor flex mat will also be installed around the new ramp. This project will result in a net fill of 64.2 cubic yards.*

f. Could erosion occur as a result of clearing, construction, or use? If so, generally describe.

*Yes, minor erosion could occur but is not likely. There will be a minimum of new disturbed areas and these areas will be isolated from surface waters with silt fences and best management practices. Work will be done in the summer months when precipitation and overland flow is minimal, thus reducing the opportunity for suspended sediments to be carried to surface waters outside the work area.*

- g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?

*Approximately 70% of this site is currently covered by impervious surfaces including concrete, asphalt, and compacted gravel. There will be no increase in impervious surfaces at this specific site as a result of this project.*

- h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any:

*Any potential erosion will be prevented using erosion control Best Management Practices. Specifically, a silt fence will be installed around upland and aquatic construction sites.*

## **2. Air**

- a. What types of emissions to the air would result from the proposal (i.e., dust, automobile, odors, industrial wood smoke) during construction and when the project is completed? If any, generally describe and give approximate quantities if known.

*Vehicle exhaust and dust from construction is expected. No long-term change in emissions is expected from the completed project.*

- b. Are there any off-site sources of emissions or odor that may affect your proposal? If so, generally describe.

*No.*

- c. Proposed measures to reduce or control emissions or other impacts to air, if any:

*Equipment will be maintained and inspected to ensure proper function of all emissions control equipment.*

## **3. Water**

- a. Surface:

- 1) Is there any surface water body on or in the immediate vicinity of the site (including year-round and seasonal streams, saltwater, lakes, ponds, wetlands)? If yes, describe type and provide names. If appropriate, state what stream or river it flows into.

*Diamond Lake is within the project site.*

- 2) Will the project require any work over, in, or adjacent to (within 200 feet) the described waters? If yes, please describe and attach available plans.

*Yes, all components of this project are directly adjacent to and within Diamond Lake. Placement of the new launch ramps and with associated Armor flex mat, and dock will occur in water. These activities are described in the attached drawings.*

- 3) Estimate the amount of fill and dredge material that would be placed in or removed from surface water or wetlands and indicate the area of the site that would be affected. Indicate the source of fill material.

*64.2 cubic yards of material will be placed within Diamond. This material will consist of concrete planks, concrete mat, and crushed rock. The area that will be affected will be in the immediate vicinity of the boat ramp. Concrete will be precast and crushed rock will be acquired from a local quarry.*

- 4) Will the proposal require surface water withdrawals or diversions? Give general description, purpose, and approximate quantities if known.

*No.*

- 5) Does the proposal lie within a 100-year floodplain? If so, note location on the site plan.

*Yes, approximately 1/2 of this site is within the 100-year floodplain.*

- 6) Does the proposal involve any discharges of waste materials to surface waters? If so, describe the type of waste and anticipated volume of discharge.

*No waste material will be discharged into surface waters.*

b. Ground:

- 1) Will ground water be withdrawn, or will water be discharged to ground water? Give general description, purpose, and approximate quantities if known.

*No.*

- 2) Describe waste material that will be discharged into the ground from septic tanks or other sources, if any (for example: Domestic sewage; industrial, containing the following chemicals. . . ; agricultural; etc.). Describe the general size of the system, the number of such systems, the number of houses to be served (if applicable), or the number of animals or humans the system(s) are expected to serve.

*No domestic or industrial sewage is onsite and no waste material will be discharged from this source. Agricultural chemicals will not be applied as part of this project or as a result of this project.*

c. Water Runoff (including stormwater):

- 1) Describe the source of runoff (including storm water) and method of collection and disposal, if any (include quantities, if known). Where will this water flow? Will this water flow into other waters? If so, describe.

*The source of runoff at the construction site would be precipitation, which is expected to be minimal during the summer construction period. Storm water treatment will not be changed or affected in any way. Currently storm water flows from driving surfaces and is infiltrated within grass filter strips at the edge of roadways and also at a catch basin located next to the ramps.*

- 2) Could waste materials enter ground or surface waters? If so, generally describe.

*With the implementation of impact minimization measures, no waste materials are anticipated to enter ground or surface waters.*

- d. Proposed measures to reduce or control surface, ground, and runoff water impacts, if any:

General Impact Reduction Measures

1. *Any storm water runoff will be contained using erosion control Best Management Practices. Specifically, a silt fence will be installed around upland construction sites to filter sediment which may be suspended in runoff water.*
2. *A turbidity curtain will be installed around the perimeter of launch installation to prevent sediment laden water from impacting surface waters.*
3. *Equipment will be washed before entering the job site and inspected daily for fuel or lubricant leaks.*
4. *Equipment staging and fueling areas will be completely isolated from surface waters to avoid the possibility of impacts to surface waters resulting from fueling or staging activities.*

**4. Plants**

*Disturbance of vegetation will be avoided. Some maintained grass areas may be disturbed and will be reseeded.*

*No threatened or endangered plant species are known to occur in this area.*

- d. Proposed landscaping, use of native plants, or other measures to preserve or enhance vegetation on the site, if any:

*Native shrubs will be planted on portions of this site as mitigation for project impacts.*

*Waterfowl species use this area as part of a migration route.*

*To preserve fish and wildlife resources, WDFW will schedule this project during periods that result in minimal effects on waterfowl species and also minimize work within water to avoid any harmful impacts upon fish species.*

*The completed project will not require energy consumption.*

*This project will not affect solar energy use.*

*No energy conservation features are included and no impacts are anticipated.*

*Materials likely to be present include gasoline and diesel fuel, hydraulic fluid and lubricants. An accidental spill of one these products could occur during project operations.*

*None anticipated.*

- 2) Proposed measures to reduce or control environmental health hazards, if any:

*A spill prevention and pollution control plan will be prepared by WDFW project engineers to reduce risk of spills and to provide guidance if a spill occurs.*

*None.*

*Increased levels of noise during construction activities are expected from this project. Hours of increased noise levels will be 7am to 6pm. No change in noise level is expected from the completed project.*

*None planned.*

*The current use is a public boat launch with vault toilets and parking. The adjacent properties include several private home sites.*

b. Has the site been used for agriculture? If so, describe.

*No agricultural practices occur here.*

*Structures on this site include a vault toilet, a sign, a double boat ramp, parking area, and a perimeter fence.*

d. Will any structures be demolished? If so, what?

*Two concrete boat ramps will be demolished and replaced.*

e. What is the current zoning classification of the site?

*Public Land*

f. What is the current comprehensive plan designation of the site?

*Public Land*

g. If applicable, what is the current shoreline master program designation of the site?

*Urban*

h. Has any part of the site been classified as an "environmentally sensitive" area? If so, specify.

*The outlet area of Diamond Lake is classified as Diamond Lake Wetlands, which is an environmentally sensitive area listed in WDFW Priority Habitats and Species Database. This wetland is over one mile from the project site.*

i. Approximately how many people would reside or work in the completed project?

*No people reside or will reside on this site.*

j. Approximately how many people would the completed project displace?

*None*

k. Proposed measures to avoid or reduce displacement impacts, if any:

*None*

l. Proposed measures to ensure the proposal is compatible with existing and projected land uses and plans, if any:

*This project will be evaluated by Pend Oreille County. Land use compatibility will be reviewed at this time.*
