DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: BEEBE SRRINGS PHASE 4A DEVELOPMENT

Description of Proposal: This project is to improve access to the Chelan Hatchery and improve habitat conditions in Beebe Springs Creek, Chinook Spring, and Toad Creek. Projects include streambed and riparian vegetation restorations. It also includes installation of a new trail with signage with 250 square feet of crushed rock trail through Wetland F with fill of approximately 112 square feet of Wetland F. The proposed hiking trail would connect the Chelan Hatchery with the scenic areas in the vicinity of Toad Creek, and on top of the adjacent bluff. The portion of the trail along the low-lying part of the site is planned to be ADA accessible. This is an expansion of work previously proposed in DNS #11-094 BEEBE SPRINGS NATURAL AREA ACCESS DEVELOPMENT issued November 22, 2011.

Location of Proposal: near the Columbia River (Lake Entiat) on a portion of the 64-acre Washington State Department of Fish and Wildlife property adjacent to US 97 and across the road (east) from the Chelan Fish Hatchery. Washington, Chelan County; Section 20, Township 27 North, Range 23 East WM

Lead Agency: Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law¹ does not require an environmental impact statement (EIS). WDFW made this determination of nonsignificance (DNS) after we reviewed the environmental checklist and other information on file with us.

We issued this DNS according to state rules.² We will **not act on this proposal for 14 days** from the date we issued the DNS. Agencies, affected tribes, and members of the public are invited to comment on this proposal or DNS. We must receive your comments within 14 days of the date of this letter. This means we must receive your comments by **March 15, 2012**
