## ENVIRONMENTAL CHECKLIST

Purpose of checklist:

The State Environmental Policy Act (SEPA), chapter 43.21C RCW, requires all governmental agencies to consider the environmental impacts of a proposal before making decisions. An environmental impact statement (EIS) must be prepared for all proposals with probable significant adverse impacts on the quality of the environment. 

The project will need a Hydraulic Project Approval (HPA) and a Lewis County Critical Ordinance Exemption.

The work will be conducted within approximately 2580 feet of ditch (see map) on the Kiona Unit of the Cowlitz Wildlife Area. The work will be performed using a backhoe and/or a track hoe to remove vegetative debris, debris dams and soil/silt deposits. Deepening the ditch is not proposed but rather to remove only enough material to remove the vegetation and its roots maintaining the historical grade. The material removed will be side cast and spread out along the ditch bank adjacent to the dirt access road. In addition two existing (plugged or partially plugged) 18" CMP culverts will be removed and replaced with 36" CPP. The work will be conducted in the dry or the work zone will be isolated from the remaining ditch by the utilization of coffer dams allowing dewatering of the work zone.

The purpose of this project is to restore ditch drainage to working order. Currently plugged undersized culverts, reed canarygrass and siltation / sedimentation are preventing proper flow. The impounding of the water within the ditch is causing the water levels to rise above the banks of the ditch and flooding adjacent fields. The flooding is persistent preventing management of the fields for winter waterfowl and elk forage. The lands were purchased as mitigation for habitat lost due to inundation by Tacoma Power's FERC project on the Cowlitz River.



Squaw Creek runs through the center of this wildlife area unit and is immediately adjacent to the project location. Additionally Spring Creek, a man-made ditch immediately adjacent to the north, directs spring water away from the fields in an easterly direction. Both water bodies drain to a wetland known as Oliver Creek Wetland Complex. Kiona Creek recently left its channel upstream of the property braiding across private property. This is an old historic route for Kiona Creek and now a good portion of the stream flows into an agricultural ditch within the southern portion of the project. This occurs during winter months and the ditch is generally dry by summer.
