## ADDENDUM TO DETERMINATION OF NONSIGNIFICANCE DATED: July 26, 2012

## Name of DNS: #12-057 DURR ROAD BRIDGE

#### **Description of DNS:**

The Durr Creek bridge (60' x 12') is proposed to replace the at-grade ford. The bridge will remove motor vehicles and associated pollutants from the creek bed and is designed with the bridge stringers above the of the 100-year flood elevation. Umtanum Creek, a perennial creek, is used by migrating and spawning steelhead. The project area is approximately 150 feet long by 40 feet wide.

  None were found at or in proximity to the site.

Should any cultural resources be identified within the project area during the operational phase, work will cease in that area and a professional archaeologist will be notified immediately and a site protection plan will be developed.

Based on the original environmental checklist and the updated information provided in this addendum, we have determined that a new threshold determination is not warranted. There is no comment period associated with this SEPA environmental checklist addendum.
