### DETERMINATION OF NONSIGNIFICANCE (DNS)

**Name of Proposal:** DORMAIER PYGMY RABBIT ENCLOSURES

**Description of Proposal:**

We propose to construct a 5 acre fenced enclosure of native shrub-steppe habitat on the Dormaier Unit of Sagebrush Flat Wildlife Area as a temporary holding area for reintroduced Columbia Basin pygmy rabbits. The final enclosure will be six to seven feet high, with 12-18 inches of the fence buried below the soil surface to exclude predators. Fence panels are composed of ½” x 1” welded wire. The support structures for the fence will be 7 foot wooden post, with steel t-posts placed between wooden posts. A number of artificial burrows will be dug in deeper soft soils to provide shelter for introduced rabbits. The enclosure will be a temporary structure that will be removed. Once removed, any habitat disturbed during construction will be replanted and the site recovered.

Agencies, affected tribes, and members of the public are invited to comment on this proposal or DNS. We must receive your comments within 14 days of the date of this letter. This means we must receive your comments by **August 15, 2012**.
