# **DETERMINATION OF NONSIGNIFICANCE (DNS)**

Name of Proposal: CHESTER BUTTE SHRUB STEPPE RESTORATION

# **Description of Proposal:**

Conversion of old ag lands, formally planted with non-native grass species, to shrubsteppe habitat. Project requires multiple steps but essentially involves replacing existing non-native vegetation with native grass and forb species.

The project site is located on the Chester Butte Unit of the Sagebrush Flat Wildlife Area. This property is owned and managed by the Washington Department of Fish and Wildlife. The total area to be restored is approximately 50 acres.

**Location of Proposal, including street, if any:** Chester Butte Unit, Sagebrush Flat Wildlife Area Washington, Douglas County; Northwest 1/4 of Section 27, Township 26 North, Range 26 East WM

**Lead Agency:** Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law<sup>1</sup> does not require an environmental impact statement (EIS). WDFW made this determination of nonsignificance (DNS) after we reviewed the environmental checklist and other information on file with us.

We issued this DNS according to state rules.<sup>2</sup> We will **not act on this proposal for 14 days** from the date we issued the DNS. Agencies, affected tribes, and members of the public are invited to comment on this proposal or DNS. We must receive your comments within 14 days of the date of this letter. This means we must receive your comments by **August 21, 2012.**
