ENVIRONMENTAL CHECKLIST

Purpose of checklist:

There are currently no plans for future additions or expansion beyond the current project proposal.

There are currently no other proposals directly affecting the property of the current proposal.

The proposed project consists of two major elements:

- 1. Demolition of existing asphalt Adult collection/holding pond and replace with two/three new concrete raceway ponds, all within the existing footprint of the asphalt holding pond. New ponds replace and maintain current pond function, but facilitate easier pond cleaning of fish waste. No net gain in impervious surface area and new pond outlets will tie into existing pond effluent line/fish ladder.
- 2. Demolition of existing pollution abatement pond and construction of new larger abatement pond to improve existing treatment of fish waste collected throughout the fish rearing cycle. Construction of the new abatement pond will be completed within the existing hatchery footprint, and constructed on existing impervious surfaces.

Replacement of the asphalt holding pond with two/three new raceways and enlarging the existing pollution abatement facilities will result in improved water quality in Forks Creek.

All proposed work associated with the proposed project will be completed on the existing developed hatchery grounds. The general descriptions of the work sites are flat.

b. What is the steepest slope on the site (approximate percent slope)?

Approximately 8 to 10 percent, proposed work area is flat.

- c. What general types of soils are found on the site (for example, clay, sand, gravel, peat, muck)? If you know the classification of agricultural soils, specify them and note any prime farmland.Soils in the vicinity are classified as Grehalem silt loam.

e. Describe the purpose, type, and approximate quantities of any filling or grading proposed. Indicate source of fill.

For the Asphalt Adult Pond demolition and new replacement concrete pond construction (2 or 3) a total of 1716 Cubic Yards of asphalt, fill, metal and concrete are planned for demolition/removal and a total of 1158 Cubic Yards of new soil, backfill, concrete, pipe bedding and asphalt for fill associated with this element of the proposed project.

For the pollution abatement pond replacement a total of 354.1 Cubic Yards of soil excavation and concrete demolition is associated with the total amount of materials to be removed with a total of 553 Cubic Yards of soil and new concrete fill for the proposed total fill associated with this element of the proposed project.

To the extent practical all cut material will be recycled. Specific quantities and types of project materials cut and fill are included in the permit drawings. All proposed work to be conducted above OHW.

f. Could erosion occur as a result of clearing, construction, or use? If so, generally describe.

No existing erosion problems are known at the site, because both the new adult holding pond and pollution abatement pond expansion will constructed of concrete, no potential erosion problems are foreseen for the proposed project. During the construction of the project the use of BMP's will be followed to prevent sediment entering the watercourse.

g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt or buildings)?

The proposed project will result in no net change in existing imperious surfaces.

h. Proposed measures to reduce or control erosion, or other impacts to the earth, if any:

Best Management practices will be used including sediment curtains and filter fabric. No sediment will enter the water or be allowed to migrate downstream. No equipment will enter the water to complete this proposed project.

2. Air

During construction, air emissions will include gaseous and potential low levels of dust. There will be no new air emissions from the completed project. When the project is completed, it will reduce gaseous emissions as future pond cleanings will be conducted with an electrical pump system; current methodology of pond cleaning is using gas driven trash pumps.

- b. Are there any off-site sources of emissions or odor that may affect your proposal? If so, generally describe. There are no off-site sources of emissions affecting the proposal.
- c. Proposed measures to reduce or control emissions or other impacts to air, if any: Standard emission control converters and mufflers would be used by construction vehicles.

Forks Creek Hatchery is located directly adjacent to Fork Creek which flows into the Willapa River.

Yes, all proposed elements of the Forks Creek Hatchery Improvement project are directly adjacent to Forks Creek.

The proposed project will not impact current existing hatchery surface water withdrawals.

A major element of the project is to expand and improve the existing hatchery pollution abatement pond and improve water quality in the hatchery effluent. All waste products collected in association with the fish rearing activities will be delivered and treated in the new expanded pollution abatement facility. No other waste products will result from the proposed project.

Proposed project will occur on the developed footprint of the existing hatchery grounds, potential slight vegetation (grass) removal associated with new expanded pollution abatement pond.

 There are no Endangered Species near the proposed project site. Spotted owl buffer edge is approximately 4,300 feet away from the project site, and marbled murrelet habitat sections are approximately 4,800 feet away from the project site.

Yes, Chum Salmon utilize Forks Creek as a migration corridor for both adult and juveniles. Fall Chinook, coho, steelhead and cutthroat trout also utilize Forks Creek as rearing habitat. This area is a migration area for Willipa Roosevelt Elk. The project also lies within the Pacific Flyway but few observations other than mergansers have been experienced at the site.

d. Proposed measures to preserve or enhance wildlife, if any:

The primary benefit of the project proposal is to improve water quality in the existing hatchery's effluent. The water quality in Forks Creek will improve with reductions in both suspended and settleable solids leaving the existing hatchery during routine pond cleaning.

6. Energy and natural resources

a. What kinds of energy (electric, natural gas, oil, wood stove, solar) will be used to meet the completed project's energy needs? Describe whether it will be used for heating, manufacturing, etc.

No new energy supplies will be needed in association with this proposal. Forks Creek Hatchery currently is supplied electrical service. Electrical services are currently and planned uses include office heating, lighting, small tools such as saws and drills, and minor office equipment, such as phone, computer, ect. The project proposal will result in a relatively small increase in electrical use but reduced gasoline use associated with routine pond cleaning at this hatchery site.

b. Would your project affect the potential use of solar energy by adjacent properties? If so, generally describe.

The project would have no effect on the potential use of solar energy by adjacent properties.

c. What kinds of energy conservation features are included in the plans of this proposal? List other proposed measures to reduce or control energy impacts, if any:
 None.

7. Environmental health

The only environmental health hazards that could occur as a result of the project are those associated with the fueling and maintenance of construction equipment. The impacts may include spill of and exposure to fuels, hydraulic fluids and lubricants.

No special emergency services will be required for this project proposal.

2) Proposed measures to reduce or control environmental health hazards, if any:

Proposed measures to reduce and control environmental health hazards include the use of best management practices associated with construction equipment fueling and maintenance. Specifically, fueling and maintenance will be conducted in a manner that will minimize the potential for spill and contamination. Spill containment and cleanup kits will be maintained onsite, and spills of fuel, hydraulic fluid, lubricants, or other hazardous materials will be cleaned up immediately with proper disposal.

b. Noise

- 1) What types of noise exist in the area which may affect your project (for example: traffic, equipment, operation, other)? There are no types of noise in the project area which will affect this project.
- 2) What types and levels of noise would be created by or associated with the project on a short-term or a long-term basis (for example: traffic, construction, operation, other)? In the short term, there will be an increase in noise associated with increased traffic and construction equipment to complete the proposed project. For long term, WDFW does not anticipate increased traffic to the site. The completed proposed project will reduce routine hatchery operational noise for pond cleaning, current pond cleaning is conducted with muffled gas trash pumps new method will utilize quieter electrical pump.
- 3) Proposed measures to reduce or control noise impacts, if any:

Project construction will occur only during daylight hours and thus will not involve night-time noise disturbances. Long term noise levels from operating the hatchery will be reduced with new electrical pumps replacing noisy gas pumps for pond cleaning.

 The proposed project site is currently used as fish hatchery. The hatchery has been historically used to hold adult fish, egg incubation, fry and fingerling rearing as well as a fish release site. Adjacent properties are Rural and largely undeveloped in nature.

The project site has not been used for agriculture.

c. Describe any structures on the site.

Current structures on the site include hatchery building, fish rearing ponds, a pollution abatement pond, water supply intake structure, short fish ladder, two staff residences and a small parking area.

Yes, the existing adult holding and pollution abatement ponds.

 No impacts are anticipated, therefore no measures are proposed.
