DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: HURD CREEK HATCHERY POND REPAIR AND POLLUTION ABATEMENT POND

Description of Proposal: Project components include resurfacing the bottom of fish rearing ponds with concrete and installing a pollution abatement pond. The pollution abatement pond requires installation of utility lines, water delivery and drain lines.

The concrete pollution abatement pond (54 feet long x 24 feet wide and 6 feet deep) will have a one foot base course gravel material.

The four existing rearing ponds (86 feet long x 27.4 wide) will be resurfaced with cast in place reinforced concrete slab.

Lead Agency: Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law¹ does not require an environmental impact statement (EIS). WDFW made this determination of nonsignificance (DNS) after we reviewed the environmental checklist and other information on file with us.

We issued this DNS according to state rules.² We will **not act on this proposal for 14 days** from the date we issued the DNS. Agencies, affected tribes, and members of the public are invited to comment on this proposal or DNS. We must receive your comments within 14 days of the date of this letter. This means we must receive your comments by **January 10, 2013**.
