**ADDENDUM 16-027 TO DETERMINATION OF NONSIGNIFICANCE (DNS) 12-004  
DATED: JANUARY 25, 2012**

**Name of DNS:** DNS 12-004 DIAMOND LAKE ACCESS RENOVATION

**Description of Original Proposal:** This project involves the renovation of an existing WDFW boat launch ramp and access site on Diamond Lake. This double ramp is scheduled to be replaced and an associated boarding float will be installed. A concrete abutment and additional ADA parking stalls will also be installed. This public access is currently open and operating but repairs are necessary to provide continued use in future years.

**Description of Addendum 16-027:** *This project involves extending both ramps at the WDFW boat launch access site on Diamond Lake. This double ramp currently does not extend deep enough to allow unrestricted launching and loading during low water periods. WDFW proposes to extend both ramps 8 feet at the bottom of each ramp. The total affected area will be 192 square feet. No fill will be used with ramp plank addition or armor flex repositioning.*

*The specific components of this project are:*

- 1. Remove the 8 foot by 42 foot section of armor flex mat at at the bottom of existing ramps.*
- 2. Install two 4 foot by 12 foot concrete ramp planks (8 additional feet of length) at the bottom of each ramp.*
- 3. Re-install the 8 foot by 42 foot section of Armor flex concrete blocking (mat) at the bottom of the extended ramp.*
