### DETERMINATION OF NONSIGNIFICANCE (DNS)

**Name of Proposal:** DNS 16-028: SCATTER CREEK WILDLIFE AREA RESTORATION

**Description of Proposal:**

Scatter Creek is home to rare plants, animals, and plant communities of remnant South Puget Sound grasslands and oak woodlands. The sites are of conservation concern due to degradation pressure from a number of threats, including invasive species and altered disturbance regimes. The project goal is to restore these rare habitats, emphasizing needs for federal- and state-listed threatened and endangered species and WDFW's Species of Greatest Conservation Need. This project will: a) acquire native seeds and transplants; b) prepare areas for seeding (prescribed fire and invasive control); c) conduct seeding and transplanting; d) control high priority invasive grasses and forbs; and e) implement integrated Scot's broom control.

Scatter Creek Wildlife Area is managed in part to restore and protect high-quality native grassland communities and wildlife populations. A major focus at Scatter Creek is recovery of two endangered butterflies, the Mardon Skipper and Taylor's checkerspot, and a medium sized mammal, the Mazama pocket gopher. Additionally, 6 of WDFW's species of Greatest Conservation Need, the Puget blue, Valley silverspot, great spangled fritillary, Sonora skipper, hoary elfin, and Oregon vesper sparrow occur in grassland habitats. The butterflies require low density of Scot's broom, short native vegetation, and specific foodplants throughout the year. The Mazama pocket gopher needs areas without dense Scot's broom. The prescribed burns are specifically delineated to provide habitat for all of these species.

Restoration goals include establishment of a roemer's fescue dominated grassland with native forbs. Restoration necessitates control of non-native prairie grasses such as tall oatgrass, sweet vernalgrass, velvetgrass, and bentgrass. Exotic herbaceous species including cat's ear, St. Johnswort, sorrel and oxeye daisy also occur extensively and require control. Fire is a pre-planting tool that kills Scot's broom effectively, reduces moss and increases bare ground. No more than 60 acres will be treated with prescribed fire and subsequent herbicide application, seeding, and planting in fall 2016 through spring 2017.

**Location of Proposal, including street, if any:** The North and South Units of Scatter Creek Wildlife Area, Rochester, Thurston County, Washington: Township 16N, Ranges 2W and 3W.

We issued this DNS according to state rules.<sup>2</sup> We will **not act on this proposal for 14 days** from the date we issued the DNS. Agencies, affected tribes, and members of the public are invited to comment on this proposal or DNS. We must receive your comments within 14 days of the date of this letter. The comment period will end at **5:00 pm on June 22, 2016**.
