Remove a portion of an inactive and unoccupied beaver dam to improve flow through the complex in preparation for piscicide treatments in Fall 2017 – 2019. A portion of the dam would be removed with hand tools and an opening approximately equal to bankfull width would be established at the dam site. The goal is to modify the inactive beaver dam to allow improved flow through the area and reduce the amount of rotenone needed to treat the complex. Additionally, the modifications to the dam will remove ready hiding places for non-native trout, reduces flow times through the complex, and improve the effectiveness of the treatment process to remove non-native fish.

Brook trout were stocked into the Sullivan Creek watershed in the 1930's, resulting in the extirpation of native Westslope Cutthroat Trout *Oncorhynchus clarki lewisi*. This project will remove non-native Eastern Brook Trout using rotenone from 2017 – 2019. In 2020, native Westslope Cutthroat Trout will be translocated into the fishless waters of Highline Creek and allowed to recolonize the watershed.


