DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: DNS 16-050: HIGHLINE CREEK BEAVER DAM NOTCHING

Description of Proposal:

Remove a portion of an inactive and unoccupied beaver dam to improve flow through the complex in preparation for piscicide treatments in Fall 2017-2019. A portion of the dam would be removed with hand tools and an opening approximately equal to bankfull width would be established at the dam site. The goal is to modify the inactive beaver dam to allow improved flow through the area and reduce the amount of rotenone needed to treat the complex. Additionally, the modifications to the dam will remove ready hiding places for non-native trout, reduces flow times through the complex, and improve the effectiveness of the treatment process to remove non-native fish.

Brook trout were widely stocked into the Pend Oreille basin beginning in the early 1900's, establishing naturally reproducing populations throughout much of the drainage. Research commissioned by Seattle City Light in 2015 found no WCT in Highline Creek, with the watershed above an historic splash dam occupied solely by brook trout. WDFW and the Kalispel Tribe Natural Resources Department propose to use rotenone to eradicate non-native eastern brook trout in Highline Creek beginning in 2017. Two to three annual treatments (2017 – 2019) will likely be required to completely eradicate non-native fish from the project area. Following the removal of non-natives, WCT would be reintroduced into the treatment section through translocation of fish (adults and/or juveniles) from nearby drainages and/or introduction of fry hatched in remote site incubators at Highline Creek. The initial phase of this project (data collection and site preparation) has been approved and funded through contract with SCL.

We are proposing to use hand tools to cut a notch in two unoccupied and unmaintained beaver dams on Highline Creek. No current (within the last year or years) beaver activity exists in the watershed above the historic splash dam. Notching the antiquated dams will allow the creek to channelize through the beaver complexes prior to treatment, reducing the treatment area behind the dams, improving flow through the complexes, and removing potential hiding spots or refugia for non-native fish. The notching is to be temporary in nature, with the dams restored to functioning condition following treatment(s).

Lead Agency: Washington Department of Fish and Wildlife (WDFW)
