

We conducted a site visit and determined this is a man-made pond which drains through a small culvert into an undefined channel. We determined that with appropriate screening this pond would be appropriate for a small number of grass carp. I recommend no more than five fish, greater than 8 inches in length, be stocked in the late spring when vegetation is growing.

The applicant must present photos of the screen system we discussed to the area habitat biologist prior to stocking.
