The Taneum Thin Forest Restoration Thinning Project is intended to improve ecological integrity ratings, create sustainable habitat for multiple wildlife species and improve forest health. Unit 1 comprises 181 acres, Unit 2 comprises 251 acres and unit 3 comprises 188 acres for a total of 620 acres treated.

Unit 1 is an industry model plantation that was planted after an even-aged harvest operation approximately 40 years ago. Approximately 300 Douglas-fir seedlings per acre were planted with good survival rates. The stand is currently over-stocked with 278 trees per acre (TPA) with an average 6" diameter at breast height (dbh). Naturally regenerated western larch and ponderosa pine are also found in the unit. Overstocked conditions, declining forest health and an increased risk of a stand replacement fire have resulted in declining ecological integrity ratings. Thinning the stand now will result in a significant increase in growth rates and overall health of the residual trees in the stand.

Leave trees in Unit 1 will be spaced at approximately 18 foot intervals, resulting in a residual leave tree density of approximately 130 TPA post thinning. This operation is a "non-commercial thinning," meaning that trees selected for removal will be dropped and left on site to decompose. Most leave trees will be Douglas-fir since that is what was planted. However, natural western larch and ponderosa pine have become established and will be the preferred leave tree species where available. Only those trees less than 8" dbh will be removed. Those trees over 8" dbh and those expressing dominant traits will be selected to leave. This operation will accelerate the successional trajectory of the stand to a late seral stand condition and potential habitat for the Northern spotted owl.

In units 2 and 3, the thinning prescription will use a combination of Individual, Clumps and Openings (ICO) techniques and stocking/spacing strategies. The complexity of the prescription necessitated the need to mark leave trees prior to the actual thinning operation. The following criteria were used during the leave tree selection process:

- **Species preference, in declining order of preference, included ponderosa pine, western larch, Douglas-fir and grand fir.**
- **Leave "unique" species that are limited to micro-sites in the stand (western red cedar and Engelmann spruce).**

- Leave large diameter “legacy” trees.
- Leave trees with good growing characteristics (good crown ratios and relatively free of pathogens and/or insect attack).
- Leave defective trees with unique characteristics (trees with cat faces, “wolfy” crowns, large limbs, etc.) for Wildlife Reserve Tree (WRT) recruitment.
- In snag deficient areas, mark trees 10” dbh and greater with defect in the butt log with 2 orange bands for WRT recruitment. This indicates to the logging contractor that he needs to “snip off” the tree as high as he can reach with the harvester to create a WRT.
- In general, attempt to leave a residual stand with a post-treatment stocking level of between 25 (average 42’ spacing) and 35 (average 35’ spacing) TPA. Realize that these stocking/spacing guidelines are only intended as a spatial reference starting point.
- Scatter tree clumps (2 to 5 trees per clump) across the unit (e.g. desirable tree species, legacy trees, unique trees, etc.) where appropriate
- Create small openings (0.5 to 1 acre) across the unit where appropriate. Take advantage of pre-existing openings with good production of browse species where appropriate.
- Minimum diameter for leave trees is 8” dbh.
- In general, leave all trees >24” dbh unless they pose a safety threat (e. g. tree is at risk of falling over a main line road) or they are a non-preferred species with preferred species surrounding (e.g. grand fir surrounded by ponderosa pine, western larch or Douglas-fir).
- Snags will not be marked as leave trees with orange paint. All snags that do not pose a safety threat, as per L & I guidelines, are required to be left by the logging contractor. Those snags dropped for safety reasons by the logging contractor will be left in place.
- Dwarf mistletoe infected trees provide important habitat to a variety of wildlife species and will be left individually or in clumps as appropriate (lower hillside, adjacent to non-impacted tree species, draw bottoms, etc.). The goal will be to reduce the threat of the mistletoe spreading to adjacent host species and throughout the stand.

The project will be accessed using existing roads, including the green dot Shadow Creek and Moonlight Canyon Roads. Access to interior portions of the units will be primarily on existing orphaned/abandoned roads. These roads will be temporarily re-opened for the duration of the project and then re-abandoned post-treatment.

Minor erosion could occur from harvesting equipment and skidders operating in the project area. There may also be minor erosion from roads and right-of-ways due to increased log truck traffic. If erosion does occur, mitigation measures including installation of straw bales, straw waddles, water bars, drain dips and grass seeding will be used as necessary. Additionally, logging operations and/or log hauling will be curtailed until mitigation measures are in place and the erosion threat has subsided.

The proposal will result in a temporary increase in vehicle emissions from logging equipment and log trucks. There should be no significant impact to air quality. Spring runoff from snow melt and rainfall runoff could occur on the forest floor, roads and landings. Water will be dispersed back into undisturbed forest areas for natural filtration through vegetation and soil. Runoff intercepted by roads and ditches will be diverted through existing culverts, water bars, drain dips and ditches to the forest floor. If the event of an extreme weather event, runoff could reach nearby streams.

There is the remote chance that fuel or oil associated with equipment operations could be spilled and potentially enter ground or surface waters. The contractor will be required to have an approved spill kit in each piece of equipment to contain and clean up spills if they should occur. Fuel storage is only allowed in approved areas. The contractor will be required to contact the WDFW Contract Administrator and the appropriate Department of Ecology Office immediately after a spill occurs.

A portion of the over story conifer trees greater than or equal to 6" diameter at breast height (dbh) will be removed. In Unit 1, approximately 150 trees per acre will be thinned, leaving approximately 130 trees per acre greater than 6" dbh post-treatment. In Units 2 and 3, approximately 2 to 3 thousand board feet (MBF) per acre (trees greater than 6" dbh) will be removed from the treatment areas.

There could be fuel spills when refueling equipment or oil spills while performing equipment maintenance. There is always the risk of fire from equipment operation in the woods. However, equipment will be required to have spark arrestors to reduce the fire risk. In addition, the contractor will be required to monitor and adhere to Industrial Fire Precaution Level (IFPL) regulations as required by the Washington State Department of Natural Resources. Burning of slash piles, resulting in temporary smoke emissions, could occur after harvest operations are completed. Additional temporary smoke emissions could be possible if prescribed fire is used as a management tool post treatment.
