A draft status report, which is titled *Draft Status Report for the Yellow-billed Cuckoo in Washington*, was prepared and provides the rationale for listing the Yellow-billed Cuckoo as endangered under Washington law. The draft status report is available for a 3-month public review from January 30 to April 30, 2017. A copy of the draft status report is submitted with this checklist. In addition, a state recovery plan will be compiled for the Yellow-billed Cuckoo if the species is listed by the Fish and Wildlife Commission.

The Washington Department of Fish and Wildlife (WDFW) has evaluated the Yellow-billed Cuckoo for possible listing as a state endangered species with the process outlined in WAC 232-12-297. One rule is proposed to be amended: WAC 232-12-014. WAC 232-12-014 identifies endangered species in Washington that are in danger of extirpation in the state and are in need of recovery actions to restore populations to healthy levels.

Pursuant to WAC 232-12-297(5.1.1) and (5.2), WDFW is proposing to amend WAC 232-12-014 and is requesting that the Washington Fish and Wildlife Commission adopt the Department's recommendation to list Yellow-billed Cuckoos as a state endangered species. Rationale for this action are presented in the *Draft Status Report for the Yellow-billed Cuckoo in Washington*. The report provides an analysis of the factors cited in WAC 232-12-297 (7.1.1) through (7.1.5) and considers all information relevant to the status of the species in Washington. The report also discusses factors affecting the species' status. As described in the report, Yellow-billed Cuckoos underwent a major decline in Washington in the early 1900s and are not believed to have bred in the state since probably the early 1940s. Since 1974, just 19 sightings of the species have been documented in Washington, representing an average rate of one sighting every 2.3 years. The main cause of the decline was likely the loss or degradation of riparian habitats caused by dam construction, flood control practices, commercial and residential development, changes in farming and ranching practices, and nonnative plant invasions. Agricultural pesticide use, which may affect prey abundance as well as the birds' health, is a potential additional threat.

Versions of the *Draft Status Report for the Yellow-billed Cuckoo in Washington* were evaluated by the scientific community, including both WDFW biologists and external scientists. As guided by WAC 232-12-297, which requires a 90-day public comment period, members of the public have been invited to review the draft report during a public comment period that extends from January 30 to April 30, 2017. After the close of the public review period, the Department will prepare the final status report and listing recommendation.

The final listing recommendation is planned to be presented to the Washington Fish and Wildlife Commission on August 4-5, 2017 and the Commission is expected to take action on the recommendation during the next meeting, scheduled to occur September 8-9, 2017.

Listing Yellow-billed Cuckoos as a state endangered species will result in accurately reflecting the conservation status of the species in Washington and may focus future management attention on this species. If the listing recommendation is adopted, WDFW will develop a recovery plan for Yellow-billed Cuckoos. This plan will set recovery objectives for the species and will discuss the various recovery strategies and tasks needed to achieve those objectives.

Proposed measures to protect or conserve plants, animals, fish, or marine life are:

WDFW will develop a recovery plan for Yellow-billed Cuckoos if it becomes an endangered species. This plan will set recovery objectives for the species and will describe the various recovery strategies and tasks needed to achieve those objectives. It would include habitat management activities to meet the needs of the species, enforcement, research, and education.

Listing of Yellow-billed Cuckoos as a state endangered species will provide some additional protective benefits under state law, mainly through increased penalties associated with the unlawful taking of the species.

Listing Yellow-billed Cuckoos as a state endangered species will impose no further land or shoreline use restrictions. This species is already designated a “priority species” under WDFW’s Priority Habitat and Species (PHS) program. This provides important wildlife and habitat information and management recommendations to agencies, landowners, municipalities, and consultants for land use planning. Specific management recommendations have not been developed for cuckoos by WDFW. Washington’s Growth Management Act requires local governments to develop critical area ordinances that address development impacts to important wildlife habitats. The specifics and implementation of critical area ordinances vary somewhat by county. If cuckoos are discovered nesting in the state, the habitat at those locations would be protected through county or municipal critical area ordinances. These ordinances require environmental review and habitat management plans for development proposals that affect state-listed and candidate species.

Western Yellow-billed Cuckoos are already listed as a federal threatened species under the Endangered Species Act and the species is protected under the federal Migratory Bird Treaty Act. Yellow-billed Cuckoos are also already designated a “priority species” under WDFW’s Priority Habitat and Species (PHS) program.
