ENVIRONMENTAL AND TRUST ASSET COMMITMENTS, EXPLANATION AND/OR COMMENTS: The WDFW has proposed to Reclamation the replacement and relocation of the existing primitive boat launch on Winchester Wasteway located off the Dodson Road and Winchester Wasteway access. The current launch site has poor access and is in a shallow/ silted in area. The new location would have better access and ease of maintenance.

A silt fence will span the entire project area prior to cutting the 300'x16' graded road and turn around. Six inches of quarry spalls will laid for the base of the road, rolled and packed, followed by 6 inches of, rolled and packed, 34" crushed rock for the top course.

The boat launch base layer would be constructed of quarry spalls covered by attaching ramp plank. The total length of the boat launch would will use 30-35 of the ramp planks.

### **National Historic Preservation Act**

## Winchester Wasteway boat launch relocation proposal:

#### Purpose of relocation:

Sediment and vegetation growth has encroached the existing site, making the launch extremely difficult to use. Summer months it is very difficult to launch and retrieve watercrafts and practically impossible during winter months. The shallow and virtually, non-moving water (at the launch) freezes up early in the winter and under normal conditions stays frozen till early spring.

Proposed new site will give improved water access for:

- Vegetation management staff
- WDFW enforcement
- WDFW research biological staff
- Search and rescue
- Public recreation

#### Operation and maintenance:

The new site would be minimal maintenance. O&M will consist of annual herbicide application along the road side and the occasional garbage removal.
