Finch Creek will require additional dredging to maintain a course that keeps it from running along the seawall. This maintenance dredging will occur under additional permitting, including an additional SEPA Checklist.

Finch Creek is the terminus stream for returning salmon utilized by the Hoodsport Hatchery. When fish enter the stream, they are immediately channeled to a fish ladder where the fish are sorted and spawned for future stocks. The mouth of the creek is a popular fishing destination for many stocks and the allowable fishing area is small in proximity with tribal fisheries to the north and private property to the south. The movement of the creek to the north has forced it to run along the seawall of the hatchery, which is the outside wall of the adult ponds. This has reduced the length of fishable stream and the available stream shoreline to fish from. A log and boulder structure will be installed using an anchor log, 8 logs with rootwads, and 2 man habitat boulders chained together with 2" chain and anchored into the substrate with beach auger anchors. The structure will be reinforced with cobble mix to provide habitat and stability of the logs. With the addition of the log structure at the corner of the seawall, DFW anticipates the creek moving to a more easterly flow to increase fishing opportunities for the public as well as protect the hatchery infrastructure.

The Hoodsport Hatchery is located along Hwy 101 within the town of Hoodsport. The hatchery is on the east side of the highway after the intersection with N Lake Cushman Rd. Finch Creek is on the south side of the hatchery and flows from the northwest. Once it reaches Hood Canal, it currently turns north and runs along the hatchery seawall. The site is located within Mason County in Section 11 of Township 22 N and Range 4W on parcel # 42212-31-60681.

While the site itself is relatively flat, the area is mountainous and there are rolling hills and mountains nearby.

    The wood structure will be within the tidal influence at high tide and some positive tides. Finch Creek will be routed away from the seawall, as the structure is within the OHW of the creek.

    Less than 30 cubic yards of material will be placed at the project. This include 6-8 foot logs

Eleven migratory birds are listed on IPaC. They are: bald eagle, black swift, Caspian tern, fox sparrow, olive-sided flycatcher, peregrine falcon, purple finch, rufous hummingbird, short-eared owl, western grebe, and willow flycatcher. Also, fall Chinook salmon, Coho, Chum, steelhead, and pink salmon are documented at the site and migrate through the area.

The site is a salmon hatchery and the inlet of the fish ladder and a pipe discharge from the facility are adjacent to the log structure proposed. Properties on either side are residential. Finch Creek, before it reaches the hatchery, is used as a fishing area.

The structure will be placed along a seawall that is also the outside wall of the adult ponds of the hatchery. Above and adjacent to the structure, a new set of stairs providing fishing access will be constructed in July 2017. To the south of the seawall is the fish ladder utilized by the hatchery. An ADA fishing pad is located above the fish ladder and the hatchery is to the west of the proposed log structure. This includes multiple buildings and ponds used for aquaculture.

Because the site is accessed by fishermen and will continue to be with the addition of the new stairs this summer (2017), it is important that the logs not obstruct the access. Logs are short and will be situated under the stairs in an effort to reduce impacts to fishing. It is also important not to hinder the hatchery's operations including the fish ladder. These elements have been considered in design of this project and the commercial aspect of the property will be upheld.

  Recreational fishing along the banks of Finch Creek has been occurring for years. When
  the creek shifted course and began flowing north sometime after 1994 and before 2003,
  fishermen experienced a more difficult time accessing the area. While a boat launch and
  access are located at the north end of the hatchery, many people choose not to use it
  because Finch Creek can be swift and deep and high tides can strand users on sand bars to
  the south. The recreational fisheries are designated between bouys in the tidelands
  adjacent to the hatchery. Parking is available onsite for users. The new stairs will improve
  access, but will put users directly in the creek. The ADA-compliant fishing platform is in
  the same area and allows disabled users to fish from above the creek.

The project will add recreational opportunities by increasing access to the creek once waters shift to a different course. The hope is that both banks of the creek will become fishable again, allowing more user access.

There are no records of any recent cultural surveys; however the hatchery buildings are over 45 years old. No evaluation has been done yet.

Although the landscape has been identified as potentially culturally sensitive location; there are no recorded landmarks, features, or other evidence of Indian or historic use or occupation. A review of historic maps and the DAHP database did not result in the identification of any recorded archaeological features within the project area.

The project was reviewed by a professional archaeologist. Context for project evaluation was derived from a review of survey and site documents available on DAHP's WISAARD database, a review of DAHP's predictive model. Portions of the project may have a low probability to impact archaeological resources. Those locations will be reviewed to clarify the expectations for intact archaeological resources. The hatchery buildings are historic; a basic inventory record exists, but will require additional documentation to meet modern standards

The results of these investigations will be used to inform final project design.
