# **DETERMINATION OF NONSIGNIFICANCE (DNS)**

Name of Proposal: DNS 17-031: HOODSPORT HATCHERY RACEWAY

**REPLACEMENT** 

# **Description of Proposal:**

WDFW is replacing the existing raceway rearing ponds at the Hoodsport Hatchery. The Hatchery property is on a small parcel with limited space adjacent to Hood Canal and Finch Creek. The scope of work is to completely demolish the existing ten (10) raceway rearing ponds (20ft x 78ft x 3ft deep) and replace them with eighteen (18) new WDFW standard raceway ponds (approximately 10ft x 78ft x 5ft deep). The project also includes demolishing and replacing some supply and drain lines. New pond drains will connect to the existing main drain outfall and new piping will connect to the existing creek gravity supply, saltwater pump supply, and re-use pump supply. The new raceways will fit within the footprint of the old raceways, and will add volume by increasing wall heights. One raceway will be modified to accommodate use as a settling pond for the incubation supply, the most sensitive rearing. An aeration tower will be constructed to increase dissolved oxygen levels in both the salt water and re-use supplies. The saltwater pumping chamber will be modified so re-use supplies can also be pumped from this chamber.

The comment period will end at **5:00 pm on June 7, 2017.**
