Hi Lisa,

There shouldn't be an issue planting 5-10 triploid (sterile) grass carp greater than 8" in this pond. As long as the sterile grass carp are purchased from a certified fish grower and are contained within the pond year round, then there shouldn't be any problems. As described in Vicki Cline's (ECY) comments and a phone conversation, the main concern was any surface water withdrawal and pumping water from this pond for irrigation purposes. A water right permit is required from Department of Ecology since the pond is located in the Dungeness Instream Flow Rule boundary.
