## **DETERMINATION OF NONSIGNIFICANCE (DNS)**

Name of Proposal: DNS 18-019: RAINEY CREEK BRIDGE STABILIZATION

## **Description of Proposal:**

The Rainey Creek Pedestrian Bridge is located near the town of Glenoma in central Lewis County. This 85' pre-fabricated gangway style aluminum bridge, installed in 2003, is open to public pedestrians to access the Kosmos Unit of the Cowlitz Wildlife Area. This bridge is in need of some moderate embankment repair and armoring to prevent further erosion of the embankment directly below the bridge's East approach and abutment. The work will entail the engineered placement of large woody debris and rocks above OHWM. Seven logs will be placed along the shoreline; five will act as toe logs parallel to the bank and two will serve as barb logs, jutting into the creek to provide habitat and help direct flows. Logs will be secured with cables and manta ray anchors and barb logs will be chained to tie down piers. There will be no excavation below OHWM and all logs will be installed by pushing into the bank. Armoring of the shoreline above the logs will be conducted using quarry spalls and geotextile fabric.

**Location of Proposal, including street, if any:** Rainey Creek Pedestrian Bridge, approximately 399 Glenoma Road, Glenoma, Lewis County, Washington: Township 12N, Range 5E, Section 22.

**Lead Agency:** Washington Department of Fish and Wildlife (WDFW)

WDFW has determined that this proposal will likely not have a significant adverse impact on the environment. Therefore, state law<sup>1</sup> does not require an environmental impact statement (EIS). WDFW made this determination of nonsignificance (DNS) after we reviewed the environmental checklist and other information on file with us.

We issued this DNS according to state rules.<sup>2</sup> We will **not act on this proposal for 14 days** from the date we issued the DNS. Agencies, affected tribes, and members of the public are invited to comment on this proposal or DNS. We must receive your comments within 14 days of the date of this letter. The comment period will end at **5:00 pm on April 13, 2018.**
