DETERMINATION OF NONSIGNIFICANCE (DNS) AND ADOPTION OF EXISTING ENVIRONMENTAL DOCUMENT (ENVIRONMENTAL ASSESSMENT)

Name of Proposal: DNS/Adoption 18-020: GOLD BASIN HABITAT RESTORATION

Description of Proposal:

The U.S.D.A. Forest Service proposes to issue the Stillaguamish Tribe a Special Use Permit to construct a live crib wall along the South Fork Stillaguamish River and sediment detention basins landward of the crib wall. Additional connected actions would include regrading disturbed materials, construction of diversion fencing upslope of the crib wall, installation of large woody structures, and site revegetation. The project would reduce delivery of fine sediment from the Gold Basin Landslide complex to the South Fork Stillaguamish River, improving salmonid habitat downstream of the project site.
