DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: DNS 18-022: HARRIS ACCESS SITE BRIDGE REPAIR

Description of Proposal:

The Harris Access Area #1 is located in the Desert Wildlife Area next to Potholes Reservoir, Grant County. It contains informal access to Winchester Wasteway South and also provides access across this waterway with a pedestrian bridge. The bridge is in good repair but the bridge abutment on the far bank is leaning towards the water and is no longer providing full support for the bridge. This abutment needs to be removed and replaced in a new location out of the stream channel. The new abutment will be placed at the top of bank and secured to protect against failure.

The specific tasks are listed below:

- 1. Lift bridge from stream using a large mobile crane. Place bridge in gravel parking for temporary storage and repair.
- 2. Remove bridge abutment on opposite bank by lifting straight-up with excavator (or crane) to prevent streambank disturbance or turbidity. Place new abutment on top of bank above Ordinary High Water. The new abutment will be placed on previously placed fill and imported material will be placed around the abutment to help secure it in place.
- 3. Remove the bridge abutment from parking lot side of the river. Place new abutment in approximately the same location. Use imported crushed rock to fill any voids and ensure correct height. Previously placed fill in this area is at least 1.5 feet deep ensuring that no disturbance will occur in native soils.
- 4. Within the isolated staging area, repair concrete spall damage on bridge and refinish deck. This task will be accomplished using hand tools and hand labor only. All concrete to be placed on the repaired portions of the bridge deck will be mixed on-site using simple hand tools and .25CY electric concrete mixer and allowed to cure for 7 days.
- 5. Re-install bridge over stream seated on new abutments. This work will be accomplished using a large mobile crane to lift the bridge from its temporary storage point on site to the perch on the new abutment.

Construct bridge approaches using imported crushed rock at the bridge ends. This task will be accomplished using a small excavator to place imported crushed rock. Material will be placed in lifts and tamped using a gas-powered walk-behind plate compactor. Final grade of approaches will be topped with a thin layer of fine-crushed rock, graded smooth with hand tools and tamped in using a gas-powered walk-behind plate compactor. 5 cubic yards of crushed rock will be imported for this task.
