



## Categorical Exclusion Form

**Project:** Replace Damaged Fuel Dock System at Keller Ferry Marina

**PEPC Project Number:** 75655

**Description of Action (Project Description):**

This project will repair the damaged Fuel Dock system at Keller Ferry Marina through the replacement of the dock floats, gangway, fuel sales office building, cable anchoring system, and utilities. This project will be completed through a design, build contract. Pre designs have been completed through a previous contract. The new dock system will have a longer, engineered, gangway and repaired bulkhead. It will have one thousand square feet of new engineered welded, steel dock framework, poly pontoons, and composite decking. A two hundred twenty five square foot fuel sales office building, fuel dispensary, and sewer pump-out will be positioned on this dock system. The current fifty foot gangway will be reattached to the existing concrete shoreline bulkhead and lengthened to accommodate lower lake elevations by attaching an additional fifty foot section of gangway. This one hundred foot gangway will be stabilized by the installation of two fifty foot piles that will be driven into the ground on either side of the gangway to eliminate horizontal movement and prevent the detachment of the gangway from the bulkhead. The dock cable anchoring system will be replaced by four fifty foot piles dispersed along the fuel dock to further eliminate any structural damage to the dock system, gangway, and bulkhead. The electric, water, sewer, and gasoline utilities will be moved from the current underwater, shore to dock route and rerouted to a utility gutter that is attached to the gangway thus eliminating underwater utilities. Bulk fuel storage will remain on shore in the current underground storage tanks. The current land-side utility services will be replaced and rerouted from overland hosing to underground piping. This will involve three hundred feet of trenching from the current point of utility water entry to the gangway.
