The Washington Department of Fish and Wildlife (WDFW) has evaluated the population status of the Sea Otter, which is currently a state endangered species. Two rules are proposed to be amended: WAC 220-610-010 and WAC 220-200-100. WAC 220-610-010 identifies endangered species in Washington as those that are seriously threatened with extinction in the state and are in need of recovery actions to restore populations to healthy levels. WAC 220-200-100 identifies species classified as protected, which are designated into three subcategories: threatened, sensitive, and other. Threatened species are those that are likely to become endangered within the foreseeable future.

Pursuant to WAC 220-610-110 (6.1.1) and (6.2), WDFW is proposing to amend WAC 220-610-010 and WAC 220-200-100 and is requesting that the Washington Fish and Wildlife Commission adopt the Department's recommendation to downlist the Sea Otter from a state endangered species to a state threatened species. Rationales for this action are presented in the *Draft Washington State Periodic Status Review for the Sea Otter*.

As described in the report, Washington's sea otter population has shown strong growth, averaging 9.5% per year since 1989 and has increased to a 3-year running average of 1,753 indivuduals from 2016 through 2017. This exceeds the downlisting objective in the 2004 Recovery Plan of 1,640 sea otters over a 3-year period. Genetic exchange with the British Columbia sea otter population is occurring, but to an unknown degree. Despite a stready increase in numbers and density, the state sea otter population remains at risk of losing significant numbers should a catastrophic event such as a large oil spill occur off Washington's coast. They remain at risk from disease, toxins, and effects of climate change. Given the steady and substantial increase in numbers and evidence of genetic exchange with the British Columbia population the sea otter no longer meets the criteria for a state endangered species. Therefore, the Department's recommendation is to list the Sea Otter as a state threatened species in Washington.

Draft versions of the *Washington State Periodic Status Review for the Sea Otter* were evaluated by the scientific community, including both WDFW scientists and external scientists. Members of the public are also invited to review the draft periodic status review during a public comment period that extends from February 6 to May 9, 2018. After the close of the public review period, the Department will prepare the final periodic status review and downlisting recommendation.

The final listing recommendation is planned to be presented to the Washington Fish and Wildlife Commission on June 15, 2018 and the Commission is expected to take action on the recommendation on August 10, 2018.

There is no direct effect on the Sea Otter population, as this action is consistent with recovering the species. The Washington Department of Fish and Wildlife bases its proposal to downlist Sea Otters from endangered to threatened on scientific

information contained in its report *Draft Washington State Periodic Status Review for the Sea Otter*. This report summarizes evidence that the Sea Otter population is increasing and is no longer threatened with extinction throughout its range in the state. The report concludes that the species should be reclassified as a threatened species.

Protective measures will remain in effect for Sea Otters in Washington if downlisting is approved. The species would become listed under the state's list of threatened species and is protected from "take", which includes hunting, fishing, and harrassement. Additional provisions are provided under the federal Marine Mammal Protection Act (MMPA). With few exceptions,the MMPA prevents the taking (defined as harassing, hunting, capturing, killing, or attempting to harass, hunt, capture or kill) and importation of sea otters and products derived from them (16 U.S.C. 1361 et seq.).

Under Washington state law (WAC 220-610-010), sea otters are protected wildlife. RCW 77.15.130 outlines that protected wildlife shall not be hunted, taken, or harassed. Sea Otters would also remain on the list of Priority Habitats and Species (PHS).
