

SEPA ENVIRONMENTAL CHECKLIST

A search of the Washington Information System for Architectural and Archaeological Records data was undertaken and there are no buildings, structures, or sites located in the Area of Potential Effect (APE).

There are no landmarks, features, or other resources within the APE; the closest cultural resources site is OL00013 (The Old Wynoonchee Foot Trail) which is located 0.60 miles to the northwest. The site dimensions are unknown. The trail was used from

1917 to 1940's and runs along the lower Wynoochee drainage-- but has been broken up by roads and clearcuts. The site has been evaluated by the SHPO and does not meet NRHP criteria.

A professional survey was completed for the Wynoochee Lake Project that covers three of the four areas discussed in this review (see reference below).
