DETERMINATION OF NONSIGNIFICANCE (DNS) AND ADOPTION OF EXISTING ENVIRONMENTAL DOCUMENT (CATEGORICAL EXCLUSION)

Name of Proposal: DNS/Adoption 18-062: ARTESIAN AND BLACK LAKES

REHYDRATION PILOT

Description of Proposal:

Artesian and Black Lakes are two historically ephemeral wetlands residing within Black Rock Coulee that have been depleted following the abstraction of groundwater within the Odessa Subarea. Further, agricultural efficiency projects within the area have reduced the incidental input contributing to these water bodies. As these water bodies have dried, waterfowl, shorebird, and aquatic habitat has been lost. Rehydration of Artesian and Black Lakes was identified as a prospective habitat enhancement project to offset impacts of implementing the Odessa Subarea Special Project within the 2013 Final Odessa Subarea Environmental Impact Statement. Washington Department of Fish and Wildlife (WDFW) has developed a pilot project to inform the feasibility of rehydrating Artesian and Black Lakes on an annual basis. This project is made possible through an agreement with the East Columbia Basin Irrigation District, U.S. Bureau of Reclamation, The Office of Columbia River (Washington State Department of Ecology), and WDFW.

The goal of this pilot seeks to recharge the shallow aquifers of Artesian and Black Lakes to the point of ponding, thereby establishing seasonal wetland habitat within the confines of the Black Rock Coulee. Construction associated with this project consists of installing a siphon on the top-side of the East Low Canal (ELC), located at the north end of the Black Rock Siphon. From there, approximately 100-150' of buried HPDE pipe will convey water from the ELC to a naturally-occurring topographic low (swale), where water will flow via gravity-assist to the mouth of Artesian Lake and beyond to Black Lake. There will be a small amount of clearing and bolstering work at the Rd. 10 culvert to reduce ponding and add support (the Grant County Right of Way permit has been acquired). Water delivery is planned to commence April-May of 2019 at a rate between 10-15 cubic feet per second (CFS). This conveyance will continue until our 2,100 acre-foot allotment has been fulfilled.
