DETERMINATION OF NONSIGNIFICANCE (DNS)

Name of Proposal: DNS 19-016: SMOOTHING IRON FOREST RESTORATION

Description of Proposal:

Approximately 280 acres of ponderosa pine and dry mixed conifer stands between 4000 and 4400 feet elevation will be commercially thinned. Sawlogs and pulp will be removed and slash piled and burned at landings. Existing and orphaned roads will be brushed, graded or reconstructed as necessary to accommodate log trucks. Logging will be done with ground-based and/or skyline cable logging systems. No new roads would be permanently built, though orphaned roads may be reconstructed along old road footprints and a few temp short spurs may be constructed. Mid seral stands will be thinned to 20-60 trees per acre or to a basal area of 40-120 feet squared per acre. Younger stands will be thinned to approximately 70 trees per acre. Ponderosa pine and larch will be preferred leave-tree species. Thinning will generally remove the smaller trees and leave the largest healthiest trees on site. Snags and hardwoods will be left on site where operationally feasible. Prescribed fire and/or tree planting may follow up thinning treatment if conditions and funding allows.

Location of Proposal, including street, if any: Approximately 20 miles southeast of Clarkston on the WDFW Asotin Creek Wildlife Area; Asotin County, Washington: Township 8N, Range 43E, Sections 1 and 2.

Lead Agency: Washington Department of Fish and Wildlife (WDFW)
